Bid should be submitted not later than 12:00 hours on 2077/12/24 (6<sup>th</sup> April 2021) Bids shall be opened in presence of bidder's representatives who choose to attend on 13:00 hours on 2077/12/24 (6<sup>th</sup> April 2021) at the office of Narainapur Rural Municipality, Narainapur, Banke. Bids remains valid for 90 days counting from the date of bid opening and must be accompanied by bid security amounting to minimum of as mentioned above for each slice. The bid security must be valid for 120 days beyond the bid validity period.
