Absence of bidder's representative in bid opening shall not obstruct the bid opening.
5. If the last date of the Bid purchasing, submission and opening falls on a public holiday, the next working day shall be considered as the last date. In such case the bid validity and bid security validity shall remain the same as specified for the original last date of bid submission.
6. In case of E-bidding, hard copy of all the required documents should be submitted within 7 days of the bid opening.
7. Bid should comply in all respects with the Instructions to Bidder included in the Bid Document. Noncompliance with this instruction will result in disqualification.
8. Bidders may submit modification or withdrawal prior to the deadline prescribe for submission of bid through e-GP system by using the forms and instructions provided by the system. Once a Bid is withdrawn, bidder will no be able to submit another bid response for the same bid.
